

OFFICIAL RULES OF THE #IWANTFESTTIX FLYAWAY CONTEST

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

Eligibility: The #iWantFestTix Flyaway Contest ("Promotion") is open to legal residents of the United States of America and Canada (except Quebec) and who are at least twenty one (21) years of age. Promotion may only be entered from and in eligible jurisdictions. Promotion Entities, prize providers, and their parent, subsidiary and affiliate companies, employees, agents and suppliers, as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible to participate. In the event of a dispute as to the identity of an entrant, the authorized account holder of the account will be deemed to be the entrant. Administrator may request any potential winner to provide proof that such person is the winner. All potential winners are subject to verification before any prize will be awarded. Subject to all applicable federal, state, and local laws and regulations. Void where prohibited. How to enter: Via internet, go to www.Ticketmaster.com/festivals, click on the #IWANTFESTTIX Flyaway Contest tab, and follow directions to submit one (1) photo in one (1) of the following three (3) Festival categories: the Faster Horses, HARD Summer, or Outside Lands category ("Category"), showing us your most epic or memorable photo from a concert or festival that you attended, include a written description in 140 characters or less on why you feel your photo is truly epic, and complete the registration form ("Submission"). Photos should be formatted to 72 dpi. Panoramic photos are not eligible. Photos should be submitted in JPG (at high quality) or GIF format. File size must be less than 2MB per photo. Unacceptable file formats: avi, mov, wmv, mp4, mpeg, flv, 3gp, and 3g2. **Only one entrant per photo.** Entries must be submitted by the original photographer. Entrants must be the registered subscriber of the email account from which the entry is made. If more than one person appears in a photo only the person submitting the Submission will be considered an entrant. You may only enter one (1) Category.

To upload a photo via Facebook or Instagram, an entrant must be a registered user of Facebook or Instagram. If an entrant is not a registered user of these sites, the entrant must visit www.facebook.com or www.instagram.com to register for free. Registration for and use of the Facebook and Instagram platforms are subject to their terms and conditions, and Promotion Entities have no responsibility with respect to such registration or use. This promotion is in no way sponsored, endorsed or administered by, or associated with, Facebook or Instagram. You understand that you are providing your information to Promotion Entities,

5. Agree to conduct yourself with due regard to public conventions and morals, and shall not do or commit any act that might prejudice the Promotion Entities during the Promotion Period and during the trip; and

Any difference between stated approximate retail value and actual value of prize will not be awarded except at the sole discretion of Administrator.

HARD Summer Festival Flyaway consisting of four (4) general admission VIP 2-Day passes to HARD Summer Music Festival at Whittier Narrows Recreation Area in South El Monte, CA, valid for August 2, 2014 and August 3, 2014; VIP access for four (4) to the official after party on August 2, 2014 at an undisclosed location to be revealed prior to event date; either round-trip charter/value economy airfare for (4) on a Funjet Vacations value flight from a major gateway airport nearest winner's residence in the continental U.S. (if winner resides in U.S.) or round-trip, coach class air transportation (if winner resides in Canada) to Los Angeles, CA departing on or about August 1, 2014 and returning August 4, 2014; one (1) standard hotel room for three (3) nights / four (4) days; and a \$250.00 pre-paid cash card to use toward ground transportation. Any difference between stated approximate retail value and actual value of prize will not be awarded except at the sole discretion of Administrator.

Outside Lands Festival Flyaway consisting of four (4) general admission 3 Day VIP wristbands ("Wristband") to Outside Lands at Golden Gate Park in San Francisco, CA, valid for August 8, 2014 through August 10, 2014; one (1) photo pass; either round-trip charter/value economy airfare for (4) on a Funjet Vacations value flight from a major gateway airport nearest winner's residence in the continental U.S. (if winner resides in U.S.) or round-trip, coach class air transportation (if winner resides in Canada) to San Francisco, CA departing on or about August

8, 2014 and returning August 11, 2014; one (1) standard hotel room for three (3) nights / four (4) days; and a \$250.00 pre-paid cash card to use toward ground transportation. Photo pass not transferable and may be used by winner only. Photo pass good for all three (3) days and valid for select artists only, subject to artist and venue restrictions. Wristband is a high-security wristband with a unique embedded barcode chip. The Wristband is treated like cash and cannot or will not be replaced if lost or stolen. The Wristband will be scanned at point of entry into festival site and at VIP areas inside the venue. Wristband should remain on winner's wrist and guest's wrist throughout the festival. Any valuation of the prize(s) stated above is based on available information provided to Administrator and the value of any prize awarded to a winner may be reported for tax purposes as required by law. Each winner is solely responsible for reporting and paying any and all applicable taxes. Each winner must provide Administrator with a valid

Voting Round: Each eligible entry will be online under the #IWANTFESTTIX Flyaway Contest tab at www.Ticketmaster.com/festivals for Peer Voting during the Voting Period. Peer must be at least thirteen (13) years of age to vote. Peer may vote no more than one (1) time each per Submission during the Voting Period. There will be three separate Categories: one for Faster Horses, one for HARD Summer, and one for Outside Lands. Peers should vote for the Submission(s) that best exemplify the most epic or memorable photo from a concert or festival pursuant to the following criteria:

- 34% Photo originality
- 33% Photo composition
- 33% Written description

The twenty-five (25) Entries in each Category with the highest overall votes ("Semi-Finalists") will advance to the Finalist Round for each Category.

Finalist Round: One (1) potential winner from each Category will be selected by a panel of judges on or about June 6, 2014 from among all Semi-Finalists as determined in Voting Round. Semi-Finalists will be judged on the basis of the following criteria:

- 34% Photo Originality
- 33% Photo Composition
- 33% Written description

Each potential winner shall be the one (1) entry that receives the highest overall score in the respective Category, as determined by the judges. In the event of a tie, there will be one (1) additional 24-hour Judging period during which Administrator representatives will vote to select the potential winner for that Category. Administrator's decisions as to the administration and operation of the Promotion and the selection of potential winners are final and binding in all matters related to the Promotion. Administrator reserves the right to disqualify any participant or winner and may refuse to award any prize to a person who is ineligible or has violated any rule, gained unfair advantage in participating in the Promotion, or obtained winner status using fraudulent means.

Selection and Verification of Potential Winners: All potential winners are subject to verification by Administrator. Administrator will not accept screen shots or other evidence of winning in lieu of its validation process. Potential winners must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. Each potential winner will be notified by mail, email or phone. In the event that a potential winner is disqualified for any reason, Administrator may award the corresponding prize to the alternate Semi-Finalist with the next highest overall score at Administrator's discretion. All alternate potential winners are subject to all requirements set forth in these Official Rules. Only three (3) alternate winners will be selected, after which the prize will remain un-awarded.

Publicity: Except where prohibited, participation in the Promotion constitutes winner's consent to Promotion Entities' use of winner's name, social media identity, likeness, photograph, voice, opinions, hometown and state for promotional purposes in connection with this Promotion in any media, worldwide, without further payment or consideration.
