

## OFFICIAL RULES OF THE 2016 STANLEY CUP® FINAL SWEEPSTAKES

**NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.**

You understand that you are providing your information to the Promotion Entities (defined below), and not to, Facebook, Twitter, Instagram or any other social network or platform.**

**Eligibility:** The 2016 Stanley Cup® Final Sweepstakes ("Promotion") is open only to natural persons who are legal residents of the fifty (50) United States of America or Canada (except Quebec) who have a valid social security or tax ID number, and who are at least eighteen (18) years of age at the time of entry. Promotion may only be entered from and in eligible jurisdictions. The National Hockey League (the "NHL") and its member teams, NHL Enterprises, L.P., NHL Enterprises Canada, L.P., NHL Enterprises, B.V., NHL Interactive CyberEnterprises, LLC (the foregoing NHL entities collectively, the "NHL Entities"), and Ticketmaster LLC (collectively with the NHL Entities, the "Promotion Entities"), prize providers, and their respective parent, subsidiary and affiliate companies, employees, officers, directors, agents, and suppliers, as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible to participate. **Sponsor:** The sponsor of the Promotion is Ticketmaster L.L.C. ("Sponsor").
