

OFFICIAL RULES OF THE 2018 NHL® ALL-STAR WEEKEND TICKETMASTER® SWEEPSTAKES

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

Eligibility: The 2018 NHL® All-Star Weekend Ticketmaster® Sweepstakes ("Promotion") is open only to natural persons who are legal residents of the fifty (50) United States of America or Canada (except Quebec) who have a valid social security or tax ID number, who are at least twenty-one (21) years of age at the time of entry. Promotion may only be entered from and in eligible jurisdictions. The National Hockey League (the "NHL") and its member teams, NHL Enterprises, L.P., NHL Enterprises Canada, L.P., NHL Enterprises, B.V., NHL Interactive CyberEnterprises, LLC (the foregoing NHL entities collectively, the "NHL Entities"), and Ticketmaster L.L.C. (collectively with the NHL Entities, the "Promotion Entities"), prize providers, and their respective parent, subsidiary and affiliate companies, employees, agents, and suppliers, as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible to participate. In the event of a dispute as to the identity of an entrant, the authorized account holder of the account will be deemed to be the entrant. Administrator may request any potential winner to provide proof that such person is the winner. All potential winners are subject to verification before any prize will be awarded. Subject to all applicable, federal, state, provincial, and local laws and regulations. Void where prohibited. For all entries: Each participant is eligible to submit up to one (1) Promotion entry per day during the Promotion Period, not to exceed a total of twenty-two (22) entries, regardless of number of entries submitted. Multiple entrants are not permitted to share the same email address or other relevant account. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated technology or system to participate is prohibited and will result in disqualification. Any automated receipt (such as one confirming delivery of email) does not constitute proof of actual receipt by Administrator of an entry. Promotion Entities are not responsible for lost, late, incomplete, invalid, unintelligible or misdirected registrations, which will be disqualified. All entries become the property of the Administrator and none will be acknowledged or returned.

Prize: One (1) Grand Prize consisting of a trip for two (2) to attend the 2018 NHL® All-Star Weekend in Tampa, FL scheduled to take place on January 27 and 28, 2018 which includes two (2) VIP tickets to attend the 2018 NHL All-Star Skills Competition™ on Saturday, January 27, 2018; two (2) VIP tickets to attend the NHL® All-Star Saturday Night Party on Saturday, January 27, 2018; two (2) VIP tickets to attend the 2018 Honda NHL® All-Star Game on Sunday, January 28, 2018; round-trip, coach class air transportation for two (2) from the major airport nearest grand prize winner's home within the 50 U.S./Canada to Tampa, FL departing January 26, 2018 and returning January 29, 2018; one (1) double occupancy standard hotel room for three (3) nights / four (4) days; a \$400.00 pre-paid cash card to use toward ground transportation; and a \$300.00 Shop.NHL.com digital gift card (subject to terms and conditions). Selection of airport(s), airline, hotel and game seat locations are solely within Ticketmaster's discretion. All other expenses not specifically mentioned herein are solely the winner's responsibility. Ticketmaster reserves the right to provide ground transportation in lieu of air transportation if the winner resides within two hundred (200) miles from event venue. Winner and guest must abide by all venue policies. Potential winner is subject to verification by Administrator. Administrator will not accept screen shots or other evidence of winning in lieu of its validation process. Potential winner will be notified by email or phone. Potential prize winner will be required to sign and return an Affidavit of Eligibility, Liability and Publicity Release ("Affidavit") and an I.R.S. Form W-9 or W8-BEN as applicable (except where prohibited), along with the Guest Affidavit, all of which must be received by Administrator within seventy-two (72) hours of the time notice or attempted notice is sent, in order to claim a prize (if applicable).
