

## **OFFICIAL RULES OF THE 2018 NHL WINTER CLASSIC™ TICKETMASTER GET THIS CLOSE SWEEPSTAKES**

**NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**Eligibility:** The 2018 NHL Winter Classic™ Ticketmaster Get this Close Sweepstakes ("Promotion") is open only to natural persons who are legal residents of the United States of America or Canada (except Quebec) who have a valid social security or tax ID number, who are at least twenty-one (21) years of age at the time of entry. Promotion may only be entered from and in eligible jurisdictions. The National Hockey League (the "NHL") and its member teams, NHL Enterprises, L.P., NHL Enterprises Canada, L.P., NHL Enterprises, B.V., NHL Interactive CyberEnterprises, LLC (the foregoing NHL entities collectively, the "NHL Entities"), and Ticketmaster LLC (collectively with the NHL Entities, the "Promotion Entities"), prize providers, and their respective parent, subsidiary and affiliate companies, employees, agents, and suppliers, as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible to participate. In the event of a dispute as to the identity of an entrant, the authorized account holder of the account will be deemed to be the entrant. Administrator may request any potential winner to provide proof that such person is the winner. All potential winners are subject to verification before any prize will be awarded. Subject to all applicable, federal, state, and local laws and regulations. Void where prohibited. **Sponsor:** The Sponsor of the Promotion is Ticketmaster L.L.C. ("Sponsor").

**Administrator:** The Administrator of the Promotion is Ticketmaster L.L.C. ("Administrator").

**Timing:** The Promotion period begins at 12:00 PM Pacific Time on November 1, 2017 and ends at 11:00 PM Pacific Time on November 29, 2017. Administrator's clock is the official time keeping device of the Promotion.

**How To Enter:** Via Internet, visit the Promotion registration page located at <http://www.ticketmaster.com/winterclassic>, and complete the registration form.

**For all entries:** Each participant is eligible to submit up to one (1) Promotion entry per day during the Promotion Period, not to exceed a total of twenty-nine (29) entries, regardless of method or combination of methods of entry or number of entries submitted. Multiple entrants are not permitted to share the same email address or other relevant account. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated technology or system to participate is prohibited and will result in disqualification. Any automated receipt (such as one confirming delivery of text message or e-mail) does not constitute proof of actual receipt by Administrator of an entry. Promotion Entities are not responsible for lost, late, incomplete, invalid, unintelligible or misdirected registrations, which will be disqualified. All entries become the property of the Administrator and none will be acknowledged or returned.

**Prize:** One (1) Grand Prize consisting of trip for two (2) which includes two (2) reserved Premium Club Level (or equivalent) tickets to the Bridgestone NHL Winter Classic™ at Citi Field in Queens, NY scheduled to take place on January 1, 2018 to include two (2) VIP pre-game field wristbands and two (2) wristbands to pre-game event; two (2) tickets to the NHL's New Year's Eve party at a to be disclosed location; round-trip, coach class air transportation for two (2) from the major airport nearest grand prize winner's home within the U.S./Canada to New York, NY or Newark, NJ, departing December 30, 2017 and returning January 2, 2018; one (1) double occupancy standard hotel room for three (3) nights / four (4) days; two (2) \$150 NHL shop digital gift cards, subject to issuer's terms; and a \$400.00 pre-paid cash card to use toward ground transportation. All other expenses not specifically mentioned herein are solely the winner's responsibility. Selection of airport(s), airline, hotel and event seat location are solely within Promotion Entities discretion. Ticketmaster reserves the right to provide ground transportation in lieu of air transportation if the winner resides within two hundred (200) miles from event venue. All potential winners are subject to verification by Administrator. Administrator will not accept screen shots or other evidence of winning in lieu of its validation process. Potential winner will be notified by email or phone. Potential prize winner will be required to sign and return an Affidavit of Eligibility, Liability and Publicity Release ("Affidavit") and an I.R.S. Form W-9 or W8-BEN as applicable (except where prohibited), along with the Guest Affidavit, which must be received by Administrator within seventy-two (72) hours of the time notice or attempted notice is sent, in order to claim a prize (if applicable).
