

OFFICIAL RULES OF THE MINIMASTER BACK TO SCHOOL SWEEPSTAKES

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

Eligibility: The Minimaster Back To School Sweepstakes ("Promotion") is open only to natural persons who are legal residents of the United States of America who have a valid social security or tax ID number, who are at least thirteen (13) years of age at the time of entry. Promotion may only be entered from and in eligible jurisdictions. Administrator reserves the right, in its sole discretion, to disqualify any individual it suspects or finds to be
