

OFFICIAL RULES OF THE TICKETMASTER® STANLEY CUP® PLAYOFFS SWEEPSTAKES

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

Eligibility: The Ticketmaster® Stanley Cup® Playoffs Sweepstakes ("Promotion") is open only to natural persons who are legal residents of the United States of America or Canada (except Quebec), who are at least eighteen (18) years of age at the time of entry. Promotion may only be entered from and in eligible jurisdictions. National Hockey League ("NHL") and its member teams, NHL Enterprises, L.P., NHL Enterprises Canada, L.P., NHL Enterprises, B.V., NHL Interactive CyberEnterprises, LLC (collectively, the "NHL Entities"), and Ticketmaster LLC (collectively with the NHL Entities, the "Promotion Entities"), and their respective parent, subsidiary and affiliate companies, employees, agents, and suppliers, as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible to participate in the Promotion. In the event of a dispute as to the identity of an entrant, the authorized account holder of the account will be deemed to be the entrant. Administrator may request any potential winner to provide proof that such person is the winner. All potential winners are subject to verification before any prize will be awarded. Subject to all applicable, federal, state, and local laws and regulations. Void where prohibited. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Administrator's decisions, which are final and binding in all matters related to the Promotion. Prizes: One (1) Grand Prize consisting of two (2) reserved tickets to one of the first four games in Round 1 of the 2015 Stanley Cup® Final ("Game"); and a \$300 NHL® Store Online Gift Certificate ("Certificate"). Tentative Game dates are will take place between May 27, 2015 and June 17, 2015. Winner must select Game at time of winner notification. Tickets are subject to availability and venue capacity. Tickets to a particular Game are not guaranteed. Selection of seat location for the Game is solely within Ticketmaster's discretion. **Travel, parking, accommodations, and all other expenses not specifically mentioned herein are solely the winner's responsibility.** Resale of Game tickets is prohibited. Winner and guest must abide by all venue policies and Game ticket terms and conditions. Ticketmaster reserves the right to revoke full or partial prize from

Selection and Verification of Potential Winners: Administrator will randomly select one (1) potential Grand Prize winner from all eligible entries on or around May 11, 2015. Once Grand Prize winner has been verified, Administrator will randomly select two (2) First Place winners from all remaining eligible entries. Administrator's decisions as to the administration and operation of the Promotion and the selection of potential winners are final and binding in all matters related to the Promotion. Administrator reserves the right to disqualify any participant or winner and may refuse to award any prize to a person who is ineligible or has violated any rule, gained unfair advantage in participating in the Promotion, or obtained winner status using fraudulent means.

All potential winners are subject to verification by Administrator. Administrator will not accept screen shots or other evidence of winning in lieu of its validation process. Potential winners must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. Each potential winner will be notified by mail, email or phone. Each potential prize winner and winner's guest may be required to sign and return an Affidavit of Eligibility, Liability and Publicity Release ("Affidavit") (except where prohibited), which must be received by Administrator within forty-eight (48) hours of the time notice or attempted notice is sent, in order to claim a prize (if applicable). If a winner and/or winner's guest is a minor in his or her state or province of residence, the Affidavit must also be executed by his/her parents or legal guardians. If a potential winner of any prize cannot be contacted, fails to sign and return the Affidavit within the required time period (if applicable), declines the prize or prize is returned as undeliverable, such potential winner forfeits the prize. In the event that a potential winner is disqualified for any reason, Administrator will award the corresponding prize to an alternate winner by random drawing from among all remaining eligible entries. All alternate potential winners are subject to all requirements set forth in these Official Rules. Only three (3) alternate winners will be selected, after which the prize will remain un-awarded.

If a potential winner is a Canadian resident, upon notification, the selected entrant, must, unaided, correctly answer a time-limited mathematical skill-testing question. Administrator reserves the right to cancel, suspend and/or modify the Promotion, or any part of it, if any fraud, technical failures or any other factor beyond Promotion Entities' reasonable control impairs the integrity or proper functioning of the Promotion Game, as determined by Administrator in its sole discretion. In such event, Administrator reserves the right to award the prizes at random from among the eligible entries received up to the time of the impairment. Administrator reserves the right, in its sole discretion, to disqualify any individual it suspects or finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and, should such an attempt be made, Promotion Entities reserve the right to seek damages from any such person to the fullest extent permitted by law. Promotion Entities' failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
